Employer Comments
This role requires a UK Military ATC Certificate of Competency. The associated military licensing requires the post to be filled by military personnel only. The role is primarily based at RNAS Yeovilton ATC with routine commitments at RNAS Merryfield Tower (satellite airfield). The controller is accountable to OC ATC under the functional authority of DSATCO. Once in post they will have the authority to conduct ATM controlling duties iaw the endorsements listed within their CoFC.
