Description of Role/Purpose: The Storeman (Combat Logistician) provides Logistical support to the Unit both in Unit and whilst deployed in support of Training Exercises and other evolutions as detailed by the Commanding Officer's Training Directive. The Storeman operates as the Unit Ammunition Storeman (Ammunition Technician).

Primary Responsibilities:

- 1. The Storeman is responsible for the following:
 - a. Provide Logistical support to the Unit and carry out any other task commensurate with rank or as required by the CoC (ULO or RQMS).
 - b. To maintain SQEP and competency conducive with UAS (Ammunition Technician) Duties.
 - c. Management of the Unit's ammunition to ensure the correct storage, issue, and transportation iaw the DLF and JSP 482.
 - d. Manage a Contracting, Purchasing and Finance (CP&F) Account on behalf of the Unit.
 - e. Produce dangerous goods paperwork for movements of ammunition.
 - f. Distribution and receipt of ammunition to/from Unit Training Exercises when required.
 - g. Manage in close liaison with the RQMS, the collection and return of ammunition natures from MOD Ammunition Depots around the UK.
 - h. Administer, regulate, and supervise the procedures for the correct return of salvage and empty ammunition containers.

Secondary Responsibilities:

- 2. The Storeman is responsible for the following:
 - a. In extremis, be prepared to support other Units with Ammunition Technician support when detailed by AO, ULO or RQMS.
 - b. Provide Duty Driver duties in rota as required to support the Unit.

Authority:

- 3. The Storeman (Combat Logistician) is authorised to:
 - a. Raise requisitions on MJDI as directed by the RQMS.

b. Raise requisitions through CP&F for Unit stationery demands as directed by the RQMS.

Line Management: The Storeman is directly accountable to the ULO via the RQMS.
